The Organiser reserves the right to charge interest on overdue accounts at 8% over base rate of Barclay's Bank plc in London, England and compensation pursuant to the Late Payment of Commercial Debts (Interest) Act 1998 and Regulations made from time to time on any late payment together with the costs of any action proceedings or activity incurred by the Supplier in recovering any sum due to it under this Agreement.
- 7. The Organiser reserves the right to pass any debt on to a third party for recovery.

- 8. Substitutions may be made at any time subject to the discretion of the Organiser.
- 9. Cancellations must be received 30 days in advance of the conference and will be subject to an administration fee of 50% of the amount charged.
- 10. Cancellations received after the 30 day period will be non-refundable.
- 11. All cancellations must be made in writing. Cancellations after this date are subject to the full admission fee.
